- Registering the Parish Council's land with the Land Registery
- Footpaths/Rights of way accessibility

- Fruit tree planting, roundabout planting and adoption, Station adoption all achieved by PC and supported by SMBC.
- Active on-going engagement between Parish and Neighbourhood Coordinator to resolve environmental issues
- 2012? Introduction by Berkswell Society of Village entry speed awareness features. Support funding from SMBC. PC Currently (currently working with consultants ARUP and SMBC Highways)
- 2017 Phone box joint funded as community information hub for Waste Lane area.
